Section 2. Hazards Identification

R10 Flammable liquid.

Section 3. First Aid Measures

INHALATION: Remove to fresh air. Keep at rest. Obtain medical attention.

EYE CONTACT: Rinse immediately with plenty of water for at least 15 mins. Contact a doctor if symptoms persist.

SKIN CONTACT: Remove contaminated clothes. Wash thoroughly with soap and water, flush with plenty of water. If irritation persists, seek medical advice.

Section 4. Fire Fighting Measures

EXTINGUISHING MEDIA RECOMMENDED: Use CO₂, Dry Powder or Foam type of extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

SPECIAL MEASURES: Avoid vapor inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing. Avoid

strong oxidizing agents.

EXTINGUISHING PROCEDURES: Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

Section 6. Accidental Release Measures

PERSONAL PRECAUTIONS: Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, water-proof boots, suitable protective clothing) in case of major spillages.

ENVIRONMENT PRECAUTIONS: Keep away from drains, soils, surface & groundwaters.

CLEANING UP METHODS FOR SPILLAGE: Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, or sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.

Section 7. Handling & Storage

PRECAUTIONS IN HANDLING: Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene, and do not eat, drink or smoke whilst handling.

STORAGE CONDITIONS: Store in tightly closed original container, in a cool, dry and ventilated area away from heat sources & protected from light. Keep air contact to a minimum.

FIRE PROTECTION: Keep away from ignition sources & naked flames. Take precautions to avoid static discharges in working area.
