### Section 2. Hazards Identification

Concentrated product. Do not ingest, use good housekeeping procedures when handling.

### Section 3. First Aid Measures

INHALATION: Remove to fresh air. Keep at rest. Obtain medical attention.

EYE CONTACT: Rinse immediately with plenty of water for at least 15 mins. Contact a doctor if symptoms persist.

SKIN CONTACT: Remove contaminated clothes. Wash thoroughly with soap and water, flush with plenty of water. If irritation persists, seek medical advice.

### Section 4. Fire Fighting Measures

EXTINGUISHING MEDIA RECOMMENDED: Use CO<sub>2</sub>, Dry Powder or Foam type of extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

**SPECIAL MEASURES:** Avoid vapor inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing. Avoid strong oxidizing agents.

**EXTINGUISHING PROCEDURES:** Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

**PERSONAL PRECAUTIONS:** Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, water-proof boots, suitable protective clothing) in case of major spillages.

**ENVIRONMENT PRECAUTIONS:** Keep away from drains, soils, surface & groundwaters.

**CLEANING UP METHODS FOR SPILLAGE:** Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, or sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.
